Notice is hereby given pursuant to Section 4-9-4 of the Ogden Municipal Code that a pending change in the right of way ordinance of Ogden City has been initiated to revise standards to:

**Eliminate the designation of new honorary street names as currently allowed by section 7 -1-2.E. of the Ogden City Municipal Code.**

It is the policy of Ogden City that new applications prohibited or subject to additional regulation under a pending ordinance be delayed until final legislative action is taken on the pending ordinance.

**Brief Description of Proposed Ordinance:**

The proposed ordinance change may result in the elimination of new honorary street names in the city. Even if honorary street names are allowed, the ordinance may also be modified to clarify the process and standards to be applied in deciding whether an honorary street name should be approved.
