ORDINANCE NO. 2021-18

AN ORDINANCE OF OGDEN CITY AMENDING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2020 TO JUNE 30, 2021 BY INCREASING THE ANTICIPATED REVENUES FOR A GROSS INCREASE OF \$1,300,000 FROM SOURCES AS DETAILED IN THE BODY OF THIS ORDINANCE; AND INCREASING THE APPROPRIATIONS FOR A GROSS INCREASE OF \$1,300,000 AS DETAILED IN THE BODY OF THIS ORDINANCE; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

WHEREAS, after due consideration, the Council of Ogden City has approved the proposed modifications as described herein.

The Council of Ogden City hereby ordains:

SECTION 1. Anticipated revenues, transfers and adjustments for the 2020-2021 budget altered, increased and decreased. The anticipated revenues, transfers and adjustments for the various funds of the 2020-2021 budget are hereby changed as hereinafter set forth, with net adjustments of \$1,300,000, as detailed in Schedule "A", which is attached hereto and made a part by reference.

SECTION 2. Appropriations from the 2020-2021 budget altered, increased and decreased. The appropriations for various funds of the 2020-2021 budget are herein altered, increased and decreased by net adjustments of \$1,300,000, as follows:

Appropriations increased since June 30, 2020 as detailed in Schedule "B", which is attached hereto and made a part hereof by reference.

SECTION 3. Effective date. This ordinance shall become effective immediately upon posting after final passage.
