**ORDINANCE NO. 2021-19**

**AN ORDINANCE OF OGDEN CITY AMENDING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2020 TO JUNE 30, 2021 BY INCREASING THE ANTICIPATED REVENUES FOR A GROSS INCREASE OF \$600,000 FROM SOURCES AS DETAILED IN THE BODY OF THIS ORDINANCE; AND INCREASING THE APPROPRIATIONS FOR A GROSS INCREASE OF \$600,000 AS DETAILED IN THE BODY OF THIS ORDINANCE; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.**

**WHEREAS**, after due consideration, the Council of Ogden City has approved the proposed modifications as described herein.

**The Council of Ogden City hereby ordains:**

**SECTION 1.** Anticipated revenues, transfers and adjustments for the 2020-2021 budget altered, increased and decreased. The anticipated revenues, transfers and adjustments for the various funds of the 2020-2021 budget are hereby changed as hereinafter set forth, with net adjustments of \$600,000, as detailed in Schedule "A", which is attached hereto and made a part by reference.

**SECTION 2.** Appropriations from the 2020-2021 budget altered, increased and decreased. The appropriations for various funds of the 2020-2021 budget are herein altered, increased and decreased by net adjustments of \$600,000, as follows:

Appropriations increased since June 30, 2020 as detailed in Schedule "B", which is attached hereto and made a part hereof by reference.

**SECTION 3.** Effective date. This ordinance shall become effective immediately upon posting after final passage.
