TSA 100% OGD ANNUAL BADGE AUDIT

As of today, Saturday, August 29th, 2020, there were 1056 that had completed the audit and 130 that have not. This is 11.6% that have **not** completed the audit. We cannot have more than 5%. Monday August 31st, 2020 concludes the audit. **All badges that have NOT successfully completed the required annual audit, will be deactivated on this coming Monday at 11:59 p.m.**

If you cannot come to the OGD Airport to complete the audit, I ask that you simply put your badge in an envelope and mail it back to us. Mail it to Airport Manager, 3909 Airport Road, Ogden, Utah, 84405. If you mail your badge and we receive it on or before August 31st, 2020, there is no fine for not completing the audit. Please call or email to ensure that we did received your badge in the

mail.

Unfortunately, if you do not return your badge and if you do not complete the audit by using your badge & PIN at any of the OGD Airport badge card reader locations, there will be a \$100 fine penalty, plus the cost to recreate your badge at the additional normal \$46. The penalty will be above the normal cost to replace your badge. Keep in mind, we do not want your money ... we want your compliance and cooperation.

If the Airport fails to account for at least 95% of its issued and unexpired AOA badges, we will be forced to terminate all badges and reissue them.

NORTH TIE-DOWN APRON CONSTRUCTION UPDATE

Because this project will demolish and replace every tie down on the north apron, we will be without approximately 40 aircraft tie-downs for the duration of the Phase One construction. On Monday, August 31, 2020, we will open up seven new tie-downs on the far south end of the east side hangar area, directly west of Axiom's and Cornerstone's business offices on Airport Road. These are referred to as the "Zulu" tie downs. The OGD Tower has adopted this name and you can use it to refer to your location when contacting OGD Ground. Because of the new seven tie-downs, I may have a couple of open tie-downs available in September. The actual seven Zulu tie-downs are going to be leased to the flight schools that are direct to the east of these new tie-downs. Please call if you need a tie-down, just don't ask for one of the new ones because they are already leased.

Right now, I have **tentative** dates for the closing of Taxiway Alpha between Taxiway Charlie & Taxiway Delta. The tower will still have the ability to assign use of both Taxiway Charlie & Taxiway Delta, but you will not be able to turn south on Taxiway Alpha from Taxiway Delta, nor can you turn north on Taxiway Alpha from Taxiway Charlie. The tentative dates are September 8th through September 18th, but these dates could slip out further into September.

Allegiant Airline's September schedule

Please note that during September Allegiant will continue serving OGD on Mondays and Fridays, but they will be arriving around 9:30 pm to 10:00 pm and departing approximately an hour later. Keep in mind this is after the OGD tower

closes. Please use caution in the vicinity of the construction and Terminal Building during the times when Allegiant is operating.
