NORTH TIE-DOWN APRON CONSTRUCTION UPDATE - A SECTION OF TAXIWAY ALPHA CLOSING FOR TWO WEEKS

On Monday, September 14th until Friday September 25th, Taxiway Alpha will be closed between Taxiway Charlie and Taxiway Delta. Expect some unusual routing from air traffic control during these days. After the tower closes, you will have to use Runway 03-21 to get around the construction, use good radio verbiage to let others know what your intentions are.

Just a reminder, the far north end of Phase 1 still has to be completed after the main area is paved. All new pavement will need to have the tie-down anchor points drilled and the concrete poured. Lastly, the lead in lines will still have to be painted.

OGD AIRPORT TERMINAL BUILDING ROOF REPLACEMENT

We will be replacing the Terminal Building roof. Clark's Quality Roofing from Murray, Utah was the lowest qualified bidder. The Terminal Building roof construction is scheduled to begin on Wednesday September 16th and should be completed towards the end of October. Please excuse the contractor's vehicles, equipment, personnel, and the dust that will be created.

WIND & WEATHER

Thank you to all that were able to move and anchor down their hangars and other facilities. A special thanks to BS2 Holdings/Apogee for cleaning up the shingles from their roof. There were several buildings / hangars damaged from the 75 mph+ winds that struck Monday night and Tuesday morning. The Airport lost the roof from the Maintenance equipment / storage hangar. It appears that Pioneer Roofing has submitted the low bid in replacing this roof. We hope to have them ready to go by this coming Wednesday. Obviously, everyone should understand the serious need to get this year's construction completed by the time the winter weather sets in.

ANNUAL TSA CFR 1542 & FAA FAR 139 TABLETOP EMERGENCY EXERCISE

On Friday, October 2nd, 2020, Ogden City Emergency Management, Ogden City Police, Ogden City Fire, and the Ogden Airport will collectively enact a table-top emergency exercise. This year's scenario will be right out of today's headlines by involving some level of civil unrest and protesting that overflows into the Airport. This exercise will meet the Airport's annual training requirements for TSA Security and FAA FAR 139 Safety. Due to COVID distancing concerns, direct attendance is extremely limited. The exercise will be held at the City's Emergency Operations Center.

Look for my next e-mail that will give the date & time for the OGD Annual Snow Meeting. This meeting is critical for coordinating each pilot's, each hangar owner's, and each business owner's ability to continue "as-normal-as-possible" operations during the upcoming winter weather. Several businesses last year
