OGD AIRPORT ANNUAL SNOW MEETING

This annual meeting is required by the FAA, as part of our FAR 139 Safety Program.

This meeting is particularly important to the flight schools, FBO's, & those with large apron areas. I usually send out specific invitations to this meeting, but if you feel that I have missed you, I will send out the Zoom information when it is acquired by this same type email. The scheduled meeting is one week from today on Thursday November 12th at 10:00am. The agenda is below:

1. Introductions

2. Requirements for this annual meeting

3. Objectives

- a. Operate a SAFE Airport, first and always
- b. Operate an EFFICIENT Airport
- c. Meet obligations of FAR 139.319 Snow & Ice Control Plan – 20 hard copies provided, and a copy was sent out with the email invite.
- d. Maximize the scarce resources that OGD must have to combat snow & ice on the airfield.
 - i. Four trained and experienced equipment operators – Three full-time and one part-time. That is it.
 - ii. Good and reasonably new equipment.
 - iii. Storms do not operate on a schedule, so OGD ends up paying a huge amount annually in overtime. Airport Manager decision to close airport.
- e. Operate OGD snow removal as a season long endeavor ... be smart.
- f. Choreograph the snow removal efforts to not be a burden on each other.
- g. Learn from our past experiences

4. Snow & Ice Control Committee (SICC) Requirements

- a. Airport Clearing Operations
- b. Air Carrier Ground Deicing/anti-icing
- c. Any Requirements for containment/collection of deicing/anti-icing

5. Snow Removal Action

- a. Activating Snow Removal
 - i. Weather Forecasting
 - ii. Chain of Command
 - iii. Initiating Snow removal
- b. Snow Control Center – Snow Desk
- c.

6. Priorities

- a. Runways FIRST, Taxiways SECOND.
- b. Runway 3-21, BEFORE Runway 17-35
 - i. Only after these two PRIORITIES are clear and safe, do we move to the next priorities
 - ii. Closing the whole Airport is acceptable, if it is unsafe.
 - iii. Time frames are based upon equipment & personnel available.
- c. FBO ramps –
 - i. Tenants have obligation to clear their leased areas
 - ii. Airport may help if time & priorities allow, however because it is likely that overtime is involved here, compensation may be required.
- d. Other ramp areas – everyone is treated the same way

7. Notifying Tenants & Public

- a. Tenant's Responsibility
 - i. Maintenance, Repair, Utilities and Storage
- b. City's Rights and Obligations

8. Snow Drifts & Disposal
