This WEDNESDAY, May 26th, 2021, there will be another scheduled water utility outage.

See the details below:

Our Contractor, Counterpoint Construction, will notify the businesses shown in the diagram below:

This is to confirm that Counterpoint will be connecting the Well House line to the system this next Wednesday 5-26-2021. We are scheduling this starting at 7 am and planning on water to be turned back on to full pressure by Noon. We will not be severing any water lines to make the connection, but pressure will need to be dropped to assure a safe connection to an exposed fitting. We expect both feeds from Airport road to the Airport to be impacted and are expecting limited to no water service during this window. Once the connection has been made and sufficiently backfilled, Water Crew will begin to pressurize the system.

OGD AIRPORT NORTH TIE-DOWN APRON RECONSTRUCTION, SCHEDULE II

Granite Construction is scheduled to begin the second half of the North Tie-Down Apron Reconstruction on Tuesday June 1st, 2021
 That is one week from tomorrow.

The initial Phase One will tear up the pavement airside of four hangars. This would be Hangars - N-1302, the northmost bay only (CB Aviation), Hangar N-1410 (CB Aviation), Hangar N-1460 (Living Scriptures - Jared Brown), and Hangar N-1504 (David Durbano). Each of these hangar owners & users should make arrangements to **not** have aircraft access in or out of their hangars between June 1st and July 19th.

Once the Phase One area has been repaved, then Phase Two will begin and multiple other hangars will lose the ability to get an aircraft from their hangar to the Runway & Taxiways.

Phase Two will block access to twenty-one (21) hangars. Each hangar owner or user will need to make arrangements to **not** have aircraft access in or out of their hangars between July 19th and August 23rd. The Hangars involved here would be Hangar N848 (Overland West), Hangar N-824 (Gerald Leslie Lautenschlager),

Hangars N-946, N-942, N-936, N-930, N-924, N-918, N-1038, N-1034, N-1028, N-1022, N-1016 & N-1010 (Owned by Hal LaFleur and lease to subtenants), Hangar N-916 (Jim Cutrubus), Hangar N-1004 (Larry Jones), Hangar 1108 (Weber County Mosquito Abatement), Hangar N-1116 (Bruce Tuttle), Hangar N-1110 (David Erickson), Hangar N-1204 (Brent Brown), and Hangar N-1302 (CB Aviation).

These dates represent the best estimates for each phase, but the actual times could vary somewhat. Keep in mind that while the new asphalt may be complete on this schedule, additional time will be required to core the tie-down anchor points and to paint in the striping and the tie-down "T"s". The full project should be complete by mid September.

Please contact me immediately, if you are one of the affected hangars and you would like to acquire a tie-down location for the duration of the construction. There will be no charge for the tie-down IF you are being cut off from your hangar during this construction. CB will be assigned approximately 27 of the tie downs completed in last year's construction.
