## **OGD AIRPORT BADGED ENTRY AND EXIT PROCEDURES**

**Long before I started as the Airport Manager, the OGD Airport Security Program (ASP) had a requirement that each and every badge-holder in a vehicle had to swipe their badge and enter their PIN number to enter the AOA and also to exit the AOA. Since each vehicle must use the card & PIN and then wait for the gate to fully close after each use, the line at the gate can become long and delayed.**

**Since we will be getting the airline traffic back in 2024 after the terminal building expansion is complete, we will continue to hold to TSA requirements. However, while entry into the AOA is required to be one at a time and each vehicle entering is required to wait until the gate fully closes and secures, TSA does not require that the Airport have the same restriction upon exiting.**

**Upon exiting, it is perfectly reasonable that the vehicle driver that opens the gate can simply pull off to the side and anyone needing to exit can drive through and exit, too. The vehicle driver who opens the gate will be**

**responsible to ensure that the vehicle gate fully closes and secures before the driver leaves the area. If the vehicle gate is found open without a legitimate badge-holder controlling the gate, the person who opened the gate will be held accountable for the security violation.**

**It should be obvious, but allowing others to exit does NOT involve allowing anyone to enter the AOA without using their badge and PIN.**

**Effective immediately, the above described changes are how vehicles can EXIT the OGD Airport.**

If you didn't catch this from my opening paragraph, the Bickering Sisters Restaurant has chosen to temporarily close during the extensive renovations of the restaurant. ## **REPLACEMENT OF THE OGD AIRPORT PILOT CONTROLLED LIGHTING**

The Airport's Pilot Controlled Lighting (PCL) equipment was installed in the late 1960's. Recently, the intensity control function began to fail intermittently. It was time to modernize and replace the old system. Last week, Mesquite Electric replaced the entire system and raised the antenna, too.
